Each remuneration review, managers are provided with a 'Rem101' training session incorporating data specific to their function/division. The information provided highlights gender gaps in remuneration prior to remuneration review to ensure managers are equipped with appropriate information to allocate the budget accordingly. Performance ratings are monitored by gender and then compared against the percentage increase allocated. Performance ratings and remuneration increases are moderated by the Executive Leadership Team.

Aurizon also provides 'Shared Care', an initiative that provides greater choice for families considering child care options for their child in the first year, where at least one partner works for Aurizon. Shared Care provides a financial incentive based on 'half-pay' for a partner to take a leave of absence to stay at home and care for their child in their first year, allowing the mother to return to work full-time. i.e. if the mother returns to work full time and partner takes unpaid leave from their employer for a period of 13-26 weeks, Aurizon will pay mother 150% of pay for that time. If the Aurizon father takes between 13 - 26 weeks off to become the primary carer for the child to allow the mother to return to work full-time (wherever that may be) Aurizon will pay the father 50% of his salary for that time. Shared Care also applies to same sex couples.

Transition to Operations
Opportunity for women in corporate areas to relinquish their role and transition into an operational environment. Participants rotate through the operational supply chain over an 18 month period.

Mentoring Circles

A mentoring circle comprises two General Managers (male and female) mentoring a group of women, focusing on business and personal development topics. Each year new mentoring circles are formed and 300+ women have participated to date. In 2017 the Circles were run in Western Australia, North Queensland, Central Queensland, Brisbane and the Hunter Valley.

Senior Women's Networking Functions

Informal networking functions for senior women within Aurizon. Events take a 'plus 1' approach with senior women nominating women at other levels within the company to attend and network.

Shared Care

An initiative that provides greater choice for families considering child care options for their child in the first year, where at least one partner works for Aurizon. Shared Care provides a financial incentive based on 'halfpay' for a partner to take a leave of absence to stay at home and care for their child in their first year, allowing the mother to return to work full-time. i.e. if mother returns to work full time and partner takes unpaid leave from their employer for a period of 13-26 weeks, Aurizon will pay the mother 150% of pay for that time. If the Aurizon father takes between 13-26 weeks off to become the primary carer for the child to allow the mother to return to work full-time (wherever she may work) Aurizon will pay the father 50% of his salary for that time. Shared Care also applies to same sex couples.

Aurizon Male Champions of Change

12 male leaders form an internal group, chaired by one of our senior leaders, to become change agents in the journey towards gender equality. The group formed in February 2015 and established a charter with individual and group actions to be undertaken.

Help at Home

Employees returning from long term parental leave are provided one-off reimbursement of up \$1500 in home and living expenses, such as child care or house cleaning to assist in the transition from parental leave to employment.

Super booster

Providing monetary and non-monetary benefits to parents returning to work after parental leave. A key component is the "Super Booster" - superannuation paid on unpaid parental leave up to 14 weeks. This is to go some way in addressing superannuation gender inequities at retirement due to breaks from paid employment

Platinum Partnership with UN Women

In 2015 Aurizon signed a three year Platinum Sponsorship with UN Women Australia. This has provided the opportunity for collaboration, speaking events for the MD and CEO on the national stage and clearly demonstrates Aurizon's support for gender diversity within and outside of the Company.

Inclusion Forums

In March 2018 a series of employee Inclusion Forums were held in various regional locations. These forums were an opportunity to raise awareness and education around Inclusion at Aurizon, including gender equality.


